Refund and Withdrawal policies

- 1: Student registration fee is paid annually, they are valid until Aug 1st of every dance season, not included in tuitions and is non-refundable.
2. All deposits are non-refundable.
- 3: All fees must be paid by pre-authorized credit cards or paid in full at time of registration.
- 4: FCDA must receive our official withdrawal form (available at front desk only) signed, filled out and dated by parents, before the 3rd Monday of any month to discontinue auto pay payments (no exceptions). Notice of withdrawal must be provided strictly to Sebastien.
- 5: Once a payment has gone through during auto pay schedule, it is non-refundable.
- 6: All costume fees (\$75.00 + HST) are non-refundable after November 1st 2015.
- 7: If a student withdraws from a class or the school, funds are not transferable.
8. No refunds or credits unless accompanied by a Doctors hand written dated note.
9. All Crew fees are non-refundable unless accompanied by a Doctors hand written dated note.
10. All credits are valid for one calendar year.
11. FCDA referral program for new student/family registration will warrant a \$25 credit to referred account (credit only awarded on full year dance tuition registrations, max of one \$25 credit given per new family referred, must acknowledge recipient during time of registration, final authorization by Sebastien only).

RELEASE AND WAIVER FORM

I further expressly agree to indemnify and hold harmless Releasees and Releasees' heirs, successors, assigns, executors and administrators against loss from any further claims, demands or actions that may subsequently be brought by me or by any persons on the account of damages of any character resulting to me in any way from the foregoing activities. I further agree to reimburse and to make good to Releasees any loss, damages, or costs Releasees may have to pay as a result of any such action, claim, or demand, including but not limited to attorneys' fees.
