- 2. All deposits are non-refundable.
- 3: All fees must be paid by pre-authorized credit cards or paid in full at time of registration.
- 4: FCDA must receive our official withdrawal form (available at front desk only) signed, filled out and dated by parents, before the 3rd Monday of any month to discontinue auto pay payments (no exceptions). Notice of withdrawal must be provided strictly to Sebastien.
- 5: Once a payment has gone through during auto pay schedule, it is non-refundable.
- 6: All costume fees (\$75.00 + HST) are non-refundable after November 1st 2015.
- 7: If a student withdraws from a class or the school, funds are not transferable.
- 8. No refunds or credits unless accompanied by a Doctors hand written dated note.
- 9. All Crew fees are non-refundable unless accompanied by a Doctors hand written dated note.
- 10. All credits are valid for one calendar year.
- 11. FCDA referral program for new student/family registration will warrant a \$25 credit to referred account (credit only awarded on full year dance tuition registrations, max of one \$25 credit given per new family referred, must acknowledge recipient during time of registration, final authorization by Sebastien only).
